Dear Wastewater Treatment Plant Operators:

The Blair County Commissioners are currently in the process of revising their Municipal Waste Management Plan. This revision is required by the Municipal Waste Planning, Recycling, and Waste Reduction Act (PA Act 101).

The new plan will update the 2002 Blair County Municipal Waste Management Plan. The update will be formatted to serve as a reference manual for public officials responsible for the implementation and coordination of various waste management programs. The main goals of the plan are to assure county residents of at least ten years of disposal capacity for waste generated within the County, to identify and provide recommendations on current solid waste management issues, and to address goals such as offering increased recycling opportunities and finding ways to increase recycling rates in the County.

On behalf of the County, Barton & Loguidice (B&L), the planning consultant for this work (with assistance from Nittany Engineering Associates), is requesting information in the form of a survey (attached) regarding your wastewater treatment facility. In general, the survey requests information on your treatment processes and how your waste products (wastewater treatment plant sludges) are handled and ultimately disposed. This information will be incorporated into the county plan.
